B4RN are pleased to announce that we are a registered supplier on the Gigabit Broadband Voucher Scheme which is provided by the Department for Digital, Culture, Media and Sport (DCMS). This scheme helps local businesses to upgrade their Internet to 1000 Mbps (1 Gbps).

Fibre-based connections offer faster, more reliable Internet connectivity, and a reliable connection is essential for businesses today—for agricultural businesses such as farms wanting to record their live stock movements and complete Single Farm Payments, or businesses wanting to connect to the Cloud and increase productivity and future-proof ready for the digital challenges of tomorrow.

The scheme helps to cover some of the costs of getting B4RN to your door. The funding is to assist with the costs of installing the service and cannot be used towards the monthly service charges.

Eligibility

Your business must be an SME or a Sole Trader/Partnership and meets the following requirements set out by DCMS:

- Employs fewer than 250 people
- Your annual turnover is less than €50M
- Balance sheet of less than €43M
- Must have received less than €200,000 of State Aid in the last 3 years. This is the *de minimus* limit and it applies to agriculture, so most farms will be eligible.
- The business must not be a subsidiary and/or under the control of a large non-SME entity
- The business operates from the premises for which the voucher is being applied (employees working from home are not eligible)

All businesses wishing to take part in the scheme must sign up for 12 months service.

Dig grant worth £150 available for businesses to install ducting within their property.

All businesses will receive a 'Free Connection' worth £150.

£150 dig grant options

- 1, You decide to dig the duct in and install the fibre boxes yourself. The dig grant will be paid to you directly by B4RN.**
- 2, You book and pay for a B4RN approved contractor to carry out the works on your behalf. The dig grant will be paid to you directly by B4RN, you will need to pay the contractor and you will be responsible for any additional costs above the grant value.**
- 3, It may be possible that your local volunteer group are able to carry out the works for you. If this is arranged then B4RN will pay the dig grant directly to the local volunteer group.**
